



## THE WISLEY

Set in beautiful Surrey countryside within easy reach of central London, The Wisley Golf Club is classed as one of the most delightful private members' clubs.

Legendary golf architect Robert Trent Jones Jr designed the 224-acre site, with three loops of nine holes combining into three different 18-hole courses. Ever since its opening in 1991 The Wisley has earned global recognition for its exacting standards and welcoming atmosphere, thanks, not least, to its 700-strong membership.

The Wisley membership is unique: there is no joining fee, private owner or syndicate. The club is owned and run by 700 men and women from all walks of life and every corner of the world. Each member owns an individual share of The Wisley Golf Club Plc. This equity share is tradable at any time and historically the shares have steadily increased in value. It's probably one of the most enjoyable investments to make.

While The Wisley is located conveniently close to the M25 and A3, it offers an oasis of tranquillity, inspired by the adjoining RHS Wisley Gardens. The course consists of three loops of nine holes, designed for players of all abilities: The Church, The Garden and The Mill. They combine to make three 18-hole courses, each with a par of 72.

Architect Robert Trent Jones Jr's vision can be felt at every hole: the course presents strategic variety to reward all players. The Wisley counts many tour professionals as members – a testament to the exceptional standards of the course.

Extensive practice facilities enable members to work on every aspect of their game throughout the year: a grass practice tee for the summer months and the most advanced artificial surface and covered bays for winter.

Equally central to The Wisley experience, the 23,000 square feet clubhouse serves as a thriving community hub. There is a large lounge area and clubroom, two bars and a gourmet restaurant, inspired by the works of Sir Edwin Lutyens. The clubhouse provides members with a perfect space to relax and recharge after a game, or to gather with family and friends for a delicious meal. On fine days, members can enjoy refreshments and light lunches on the terrace overlooking the course.

The Wisley also prides itself on a busy social calendar. Aside from numerous competitions, members' families and their guests can enjoy activities ranging from seasonal themed evenings and special dining experiences to charity events. The comfortable surroundings and incredibly attentive staff add to the club's home-from-home feel.

## THE FACILITIES

- The Surrey-based Wisley Golf Club is one of the most prestigious golf clubs in the UK.
- The Wisley was the first club in the UK to be designed by the renowned golf course architect Robert Trent Jones Jr.
- The course consists of three loops of nine holes, each of equal stature, excellent practice facilities and a clubhouse providing service and cuisine of the highest standard.
- Course maintenance standards match the very best in the world. The presentation of the course remains the club's main priority.
- Located only a few miles from the M25 and A3, the club is within easy reach of central London and the surrounding area.

## MEMBERSHIP STRUCTURE

- The 700 shareholders have complete control over their assets and the direction of the club. They own the unencumbered freehold of the course and the clubhouse.
- Membership of the club may be obtained through the purchase or rental of a share in The Wisley Golf Club Plc. Such shares become available when existing shareholders decide to sell or rent their unit.
- The playing rights attached to a share are transferable, allowing a shareholder to change the nominated member without transferring the share. Shares may also be freely traded, transferred or passed on by inheritance.

## MEMBER FACILITIES

- The facilities are for the exclusive use of the membership and their accompanied guests. The club does not permit society and corporate golf days or casual visitors.
- The club has developed a strong community spirit amongst the membership, which is drawn from a wide range of nationalities.
- All members have the same seven-day playing rights; ladies and men compete together in club competitions.
- The spouse and dependent children of a member also enjoy certain playing privileges at no additional charge.
- Membership is limited to 700, ensuring the 27 holes can accommodate members with ease at all times.
- The clubhouse offers the same commitment to the highest standards as the golf facilities. Hospitality is provided by a dedicated team of staff who take immense pride in personal service.
- The club provides a relaxed home-from-home atmosphere.
